# Metrics on Exceptional Circumstances SEP (COVID-19)

- SSHIX has released a public report listing Special Enrollment Period (SEP) enrollment figures for Dec 2019— May 2020, including detailed metrics on the recent Exceptional Circumstances (COVID-19) SEP.
- The report, which is titled "Special Enrollment Period Enrollment Figures Report Dec. 2019 – May 2020," has been posted to SSHIX's Coronivirus Response page at https://www.nevadahealthlink.com/coronavirus/

## **EDI Testing Update**

- The final version of the SSHIX Plan Year 2021 EDI Carrier Testing Scenarios worksheet has been posted to our website at <a href="https://www.nevadahealthlink.com/sshix-plan-year-2021-edi-carrier-testing-scenarios/">https://www.nevadahealthlink.com/sshix-plan-year-2021-edi-carrier-testing-scenarios/</a>.
- Testing for new carriers is scheduled to begin on Monday,
  6/29 and conclude on Friday, 9/4.
- Optional testing for returning carriers is scheduled to begin on Monday, 7/6.
- GetInsured will provide support for generation and processing of test files, as well as email notifications regarding test file status. Lacie Warren, SSHIX Reconciliation Lead, will supervise testing and provide additional policy/technical support.
- Payment Re-Direct testing is currently scheduled for September 14-25.

## **Recon Portal Update**

- SSHIX has completed development and testing of the Recon Portal's "false positive" logic and associated Dispute/Resolution workflow. By filtering out known false positives, as well as discrepancies associated with Cancelled or Termed policies, we've seen approximately a 60% reduction in the overall number of monthly discrepancies (though individual results will vary by carrier).
- Phase I, which includes the basic Dispute/Resolution workflow and bulk reporting, is scheduled for rollout next week (6/15— 6/19). Russell will be contacting carriers via email to schedule a demo/orientation.
- Phase II, which is scheduled for deployment in late July, will add the ability for carriers to submit "recon tickets" to the SSHIX Recon Team, reducing our dependence on secure email for the investigation of complex discrepancies.
- SSHIX is hoping to release the Recon Portal functionality as an integrated part of the existing "Carrier Connector" casework portal, allowing for single-sign-on access to both roles/functions. However, security testing is ongoing.
