

Enrollment Metrics Update


The figures in this table represent Nevada Health Link enrollments in Pending or Confirmed status as of 5/9/2022. Consumers enrolled in Terminated policies have been removed from these counts. Please note that consumers who are enrolled in both health and dental plans would be counted twice for each monthly total. A count of unique individuals is provided on the following slide.

Plan Certification Update

- QHP and QDP binder submission is due in SERFF on Wednesday, June 1. The QHP and QDP Plan Certification Timelines are located in the Plan Year 2023 Final Letter to Issuers, published on the <u>Carrier Resources page</u> of Nevada Health Link.
- CMS QHP Enrollee Survey data submission deadlines for eligible QHP issuers are also included in the QHP Plan Certification Timeline. Please refer to the CMS Marketplace Quality Initiatives website and the QRS/QIS sections of the PY23 Final Letter to Issuers for more information.
- At this point in the PY23 Plan Certification process, it is recommended that Issuers check the <u>Carrier Resources page</u> of Nevada Health Link regularly for updates.

Plan Certification Update (continued)



- Nevada Health Link's next major software release, which is scheduled for June 28th, will add support for a new SERFF plan data field called "Gender Affirming Care." This field will be displayed to consumers in the Summary of Benefits portion of our Plan Shopping and Enrollment module.
- It's critical that Plan Year 2023 SERFF filings include some type of language in this field, otherwise the display will default to "not available."
- SSHIX's understanding is that this type of care must be covered when deemed medical necessary, however additional information can be provided in this field if desired.



- Updated versions of SSHIX's 834 Companion Guide and Reconciliation Guide documents are still pending final approval.
- SSHIX hope to release updated versions of these documents by Friday, May 13.
- When the updated documents are released SSHIX will send an email notification to all members of the Monthly Carrier Meeting invite list.
- Please note that the new versions of the companion guides will not contain any new technical requirements—they will only provide revised guidance.

RCNI Testing Update

- Testing of the new 63-column RCNI format, which is schedule for Aug-Sep 2022, will utilize the same Nevada Health Link Carrier QA environment which was previously utilized for EDI testing.
- It's SSHIX's understanding that SFTP credentials for this environment already exist for all returning carriers. SSHIX will be reaching out to each carrier during the month of May to provide these credentials.
- New carriers will not be required to participate in this standalone RCNI testing window, as RCNI testing is already included in the standard EDI Test Plan.
- All requirements for the new 63-column RCNI format are included in the current version of SSHIX's Reconciliation Guide, which is available for immediate download from the <u>Carrier Resources page</u> of our website.

May RCNI Submission

- The next RCNI Submission Deadline is <u>Thursday</u>, <u>May 19th</u>
- All carriers are expected to submit a Plan Year 2022 RCNI in May. A Plan Year 2021 RCNI is not requested/required.
