Six Month Look-Ahead

August, 2024

- Issuer Plan Preview continues through 8/19
- Final data transfer from SERFF to NVHL is 8/28
- PY25 Draft Issuer Agreement & Policy Manual for review 8/23

September, 2024

- 9/4: Final PY25 Issuer Agreements sent to Issuers with final plan confirmation list
- 9/4 – 9/13: Issuers send signed Issuer Agreements and confirm plan listings
- 9/13: SSHIX to send final plan confirmation list and countersigned attestations and billing agreements to Issuers
- 9/13: Plans certified in SERFF

Six Month Look-Ahead (cont'd)

October, 2024

- 10/1: Window Shopping begins
- 10/1: URL links need to be live for window shopping
- 10/7 – 10/11: Limited data correction window – need state authorization
- 10/21 – 10/23: Passive Renewals Job

November, 2024

- 11/1: Open Enrollment Period begins

December, 2024

- Open Enrollment ongoing...
- 12/10 – 12/12: Schedule Passive Renewal

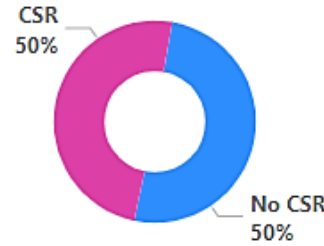

Avg Premium Before APTC**

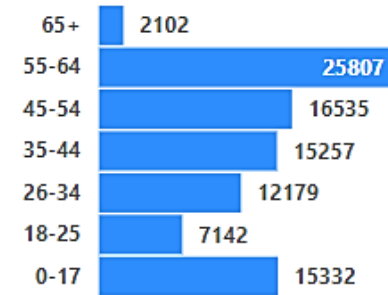
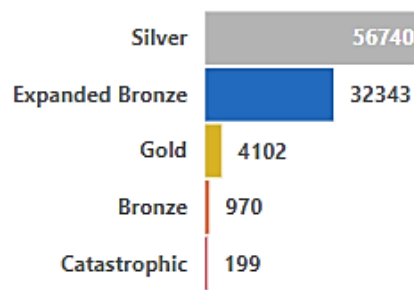

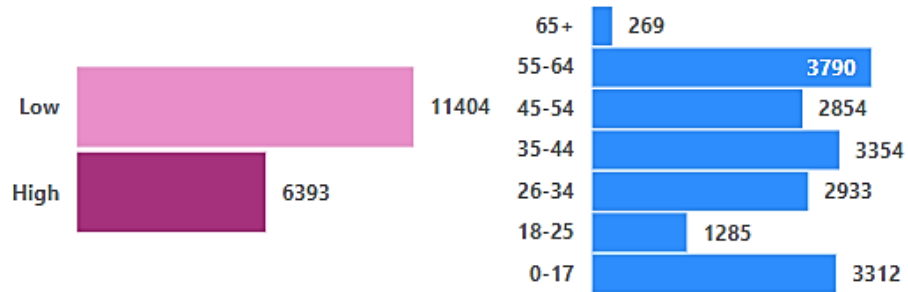

Policy Manual and Issuer Agreements

- Draft versions of the PY 25 Issuer Agreement and Policy Manual will be sent for carrier review on 8/23/24.
- Comments on both documents will be due back to the Exchange by 9/6/24.
- The original date for the Issuer Agreements was previously set for 8/16/24. However, due to previous extensions through out the plan certification process, as well as an opportunity for alignment with the Policy Manual release this will be pushed until 8/23/24.

Plan Certification

- Plan Preview ends August 19, 2024. It is essential that carriers review all plans and mark them as “Verified” prior to the completion of Plan Preview, as this is the last opportunity you will have to review plan data in the format that will be displayed to consumers.
- From this point forward, since the first data transfer occurred on 7/13, it is critical to notify Meagan Werth Ranson via email of any and all template changes that are uploaded in SERFF. This is to ensure that updates are not missed and can be re-transferred in a timely manner.
- The final data transfer from SERFF to the Nevada Health Link SBE Platform will be August 28, 2024.
- Please be on the lookout for the Plan Year 2025 DRAFT Issuer Agreements. These will be sent out in the next two weeks. I wanted to note that the original date for these agreements to go out was set for 8/16. Due to all the changes regarding the policy manual, SSHIX wants to best align this agreement with the Policy Manual. Therefore, we are extending the release date by a week. The Draft Issuer Agreements will now go out 8/23/24.

August RCNI Submission

- The next RCNI Submission Deadline is **Monday, August 19.**
- Carriers are expected to submit an RCNI for Plan Year 2024 only.
