Six Month Look-Ahead

December, 2024

- Open Enrollment ongoing...
- 12/3: First 30 Days of OEP Press Release
- 12/10 – 12/12: Schedule Passive Renewals job
- 12/24 – 12/25: SSHIX Call Center Closed for Christmas Holiday
- 12/31: Last day to submit enrollment with coverage starting 1/1/25

January, 2025

- 1/15: OEP ends at 11:59 PM
- All plan selections made in January will have a 2/1/25 effective date
- 1/20: MLK Jr. Day – Federal Holiday, Closed
- 1/21: Last day to enroll in a plan with a 2/1 effective date for consumers who submitted an application by 1/15
- 1/21-1/27: 1095As released/generated after OEP
- 1/25 (-ish): Post OEP Press Release

Six Month Look-Ahead (cont'd)

February, 2025

- Special Enrollment Period
- Intent to Sell and Intent to EDI Test forms distributed to Issuers

March, 2025

- Special Enrollment Period

April, 2025

- Intent to Sell forms are due 4/1/25 from Issuers

May, 2025

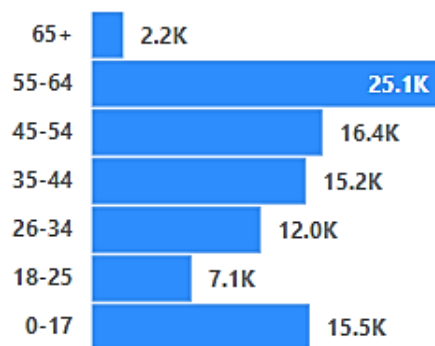
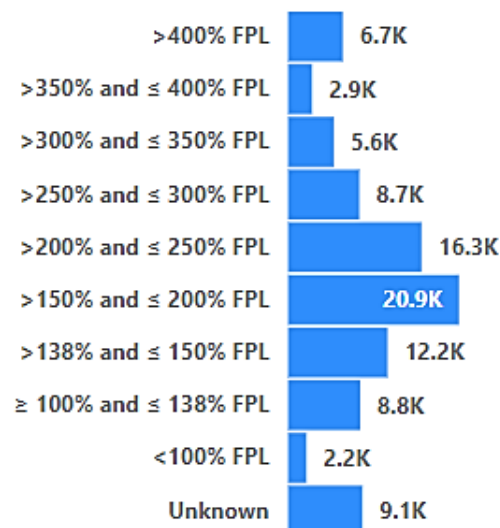
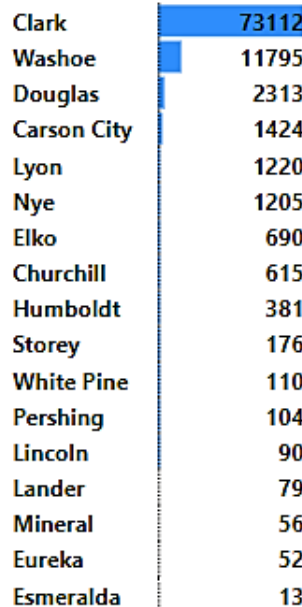
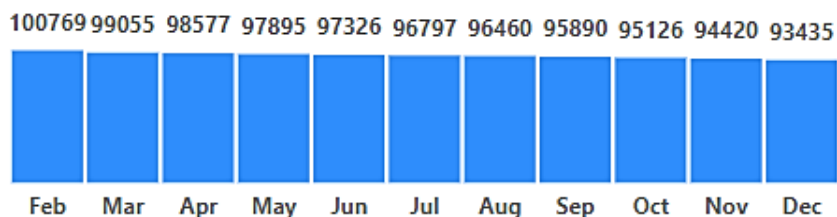
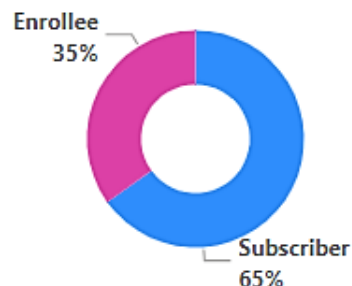
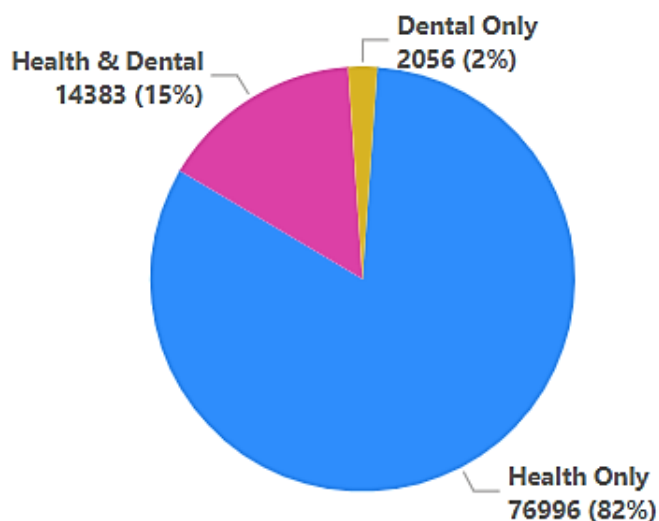
- Plan Year 2026 Binders prepared for initial Binder Submission deadline in late May/early June.

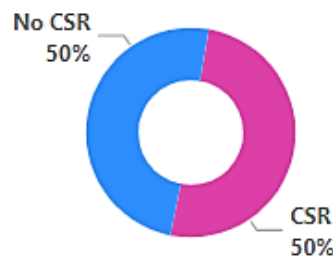
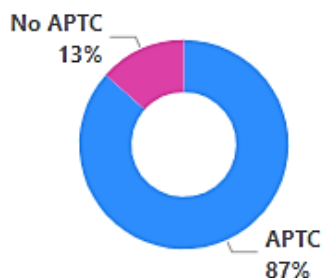

Avg Premium Before APTC**

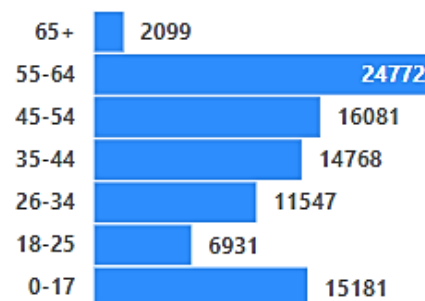
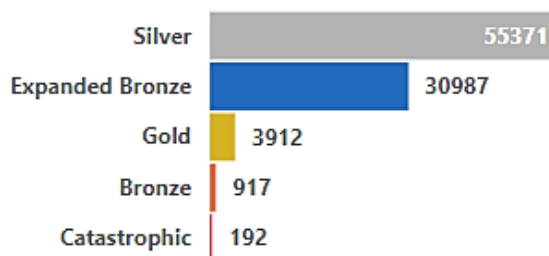

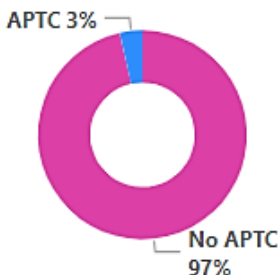

PY 2025 Open Enrollment Update

- Between 11/1/24 – 12/7/24, SSHIX has processed 22,399 Active Health Plan Selections and 5,609 Active Dental Plan Selections. These figures include both New Enrollees and Active Re-Enrollees.
- As of 12/7/24, SSHIX is tracking 96,716 unique Health enrollees and 19,109 unique Dental enrollees in Pending or Confirmed status.
- As of 12/7/24, 106,088 unique individuals have been found eligible for a Plan Year 2025 QHP, of which 91,561 (or ~86%) have been found eligible for APTC and/or CSRs.

ICHRA and QSEHRA Enhancements

- As we reported in November, SSHIX will be adding ICHRA/QSEHRA indicators to 834 Initial Enrollment (ADD) transactions related to SEP enrollments in late March of 2025.
- Following the November presentation, some questions were raised regarding the ability of issuers to leverage these indicators to satisfy CMS' reporting requirements.
- At present, we believe the ICHRA indicator can be used to identify whether the Primary Subscriber has been offered an ICHRA.
- The reporting requirements for QSEHRA, however, require issuers to distinguish between the offer of a QSEHRA to be used to pay towards the monthly premium payment, versus a QSEHRA to be used to pay towards their medical and/or pharmacy claims. ***At present we are unsure if the proposed implementation will be able to support this distinction, but we're actively working with our vendor to determine if this will be possible.***
- SSHIX will continue to provide updates as additional information becomes available.

December RCNI Submission

- The next RCNI Submission Deadline is **Thursday, December 19.**
- Carriers are expected to submit an RCNI for Plan Year 2023, 2024 and 2025.
