I. SSHIX Advisory Board and Division of Consumer Health Services Staff

During the 83rd Nevada Legislative Session Senate Bill (SB) 494 revised the Silver State Health Insurance Exchange's (SSHIX or Exchange) Executive Board from a governing to an advisory body, restructured board composition, and redefined the voting and non-voting board roles.

Also during the 83rd session, the passage of Senate Bill (SB) 97 requires one of the two members of the Board appointed by the Governor, be a member of an Indian Tribe located in this State, with expertise in health care administration. The Exchange Advisory Board is comprised of seven (7) voting members and one (1) non-voting member as listed below.

II. Introduction

The Silver State Health Insurance Exchange (Exchange) is a state agency within the Nevada Health Authority (NVHA; The Authority) within the Division of Consumer Health Services. The Exchange facilitates the sale of qualified health and dental plans for eligible Nevadans on NevadaHealthLink.com, the online health insurance Marketplace.

On July 1, 2025, the Exchange was moved under the NVHA, Division of Consumer Health Services, as a result of the passage of Senate Bill (SB) 494 in the 83rd Nevada Legislative Session.

As the largest unit within the Division of Consumer Health Services, the Exchange has been primarily focused on transitioning into a new division, setting priorities and goals in support of the Nevada Health Authority, and ensuring a successful Plan Year 2026 for Nevada Health Link's Open Enrollment Period (November 1, 2025 – January 15, 2026).

III. Advisory Board Meetings

The Advisory Board met in December 2025 to receive updates on the transition to the Nevada Health Authority, introduce newly appointed members and staff, as well as discuss election of a Chair and Vice Chair for the Board, and act on key administrative items, including approval of updated Exchange bylaws and the Advisory Board Annual Report. In addition, the Board met to approve the semi-annual Fiscal & Operational Report that will be sent to the Governor's office, heard presentations from the Exchange Executive Officer and Consumer Health Services Division Administrator, and discussed dates, times, and agenda items for future meetings.

VI. Conclusion

The current reporting period of 2025 represents a pivotal stage in the transition from a governing board to an advisory board of the Silver State Health Insurance Exchange. As of December 2025, the Advisory Board has appointed members and the Exchange and Division of Consumer Health Services will work together to complete foundational work necessary to support the goals of the Nevada Health Authority (NVHA), including streamlining roles and responsibilities with staffing, new projects for the next biennium as it relates to the enrollment platform and options for Nevadans to gain access to qualified health plans and insurance coverage.
