

Six Month Look-Ahead

December 2025

- No updates OEP
- 12/10 12/12: Secondary Passive Renewals (SPR) Job

January 2026

- Open Enrollment ongoing
- 1/15 Open Enrollment ends at 11:59 PM
- 1/20 Consumers will have 5-day buffer after completing application to select a plan for PY26 coverage

February 2026

No updates

March 2026

- SSHIX to send out Intent to Sell and Intent to EDI Test forms
- SSHIX to reach out to Insurance Carriers for updated POC forms

Six Month Look-Ahead

April 2026

Intent to Sell forms due from issuers on 4/1/26

May 2026

- Plan Year 2027 Binders prepared for initial Binder Submission deadline in late May/early June.
- Mid May: CMS QHP Enrollee Survey data submission deadline
- Late May: HHS-approved QHP Enrollee Survey vendor securely submits the survey response data to CMS on behalf of the QHP issuer






December 2025 Enrollment Summary







Health Enrollees – All Counties





PY26 Open Enrollment Update



- Between 11/1 -12/8, SSHIX has processed 29,652 Active Health Plan Selections and 3,298 Active Dental Plan Selections. These numbers include both New Enrollees and Active Re-Enrollees.
- As of 12/8, SSHIX is tracking 99,886 unique Health enrollees and 19,379 unique Dental enrollees in Pending or Confirmed status.
- As of 12/8, 112,729 unique individuals have been found eligible for a Plan Year 2026 QHP, of which 89,092 (or 79%) have been found eligible for APTC and/or CSRs.

Policy Updates



The 36th (2025) Special Session convened on November 13, 2025 at 10:07 AM and adjourned *sine die* on November 19, 2025 at 10:19 PM.

State Updates

- SB4 (Sec. 10) Broker Compensation Funding
 - Appropriations to compensate brokers for enrolling individuals in Public Option plans.
- SB4 (Sec. 11) Community Outreach Grants
 - Allocations for grants to community-based organizations to support education and enrollment in Medicaid and Public Option plans.

December RCNI Submission

- The next RCNI Submission Deadline is **Thursday, December 18.**
- Carriers are expected to submit an RCNI for Plan Year 2024, 2025 and 2026.
